#### Update from the Board: Darla Yonkman and Jim King

- -Austin Shaw is a BTPS nomination for Edward Parr Award.
- -The Board is penning a letter to Minister LaGrange regarding curriculum including delaying curriculum, funding and increase in funding to prepare for curriculum, and they want to know whether resources will be ready for teachers. If staff have any additional concerns please forward to Darla and Jim
- -At the last board meeting we had students from different schools talk to the board, we had Wainwright, Dewberry and Hughenden. They spoke about perseverance within schools. Preliminary budget- 70 million to Charter Schools- Questions about how Charter Schools affect the funding in districts
- -Superintendent Public Speaking Contest is coming up April 29.
- -Funding model: Funding model has been hard on all schools and a challenge for Trustees. Still want the government to look at the funding model.

- -International students initiative started a few years ago has been tabled

## Safety School Inspections

- -Health inspector was out and found a burned out light bulb in the freezer, and the hood vent over grill should be professionally cleaned- both of these have been addressed.
- -On March 16 JR had complaints to OHS that there were unsafe conditions in school. A representative from Edmonton, a BTPS team including Mr. Bates, Don Doherty, Custodial Supervisor, and BTPS OHS committee member.

Complaints were that there were non vaccinated staff and students were not wearing masksthese were made after March 1 when the Province moved to Stage 2. OHS said they do not have legal jurisdiction to deal with unvaccinated staff or unmasked students- all other safety elements were in place.
